THE FOLLOWING TERMS AND CONDITIONS (“GP”) GOVERN THE TERMS AND CONDITIONS OF YOUR ENTRY APPLICATION AND YOUR EVENTUAL ADMISSION AND PARTICIPATION IN THE 2021 HILL CLIMB “BERNINA GRAN TURISMO” (the “Event”), from September 16TH to September 19TH. BY ACCEPTING THE “GP” BELOW, YOU ARE RECOGNIZING AND ACCEPTING THE FACT THAT THEY WILL GOVERN YOU FOR ALL THE FEATURES REGARDING YOUR PARTICIPATION AT THE MENTIONED EVENT AND YOU ARE RECOGNIZING AND ACCEPTING THE HILLCLIMB “BERNINA GRAN TURISMO” REGULATIONS. THE GERMAN VERSION OF THESE GP SHALL BE BINDING. IN THE EVENT THAT YOU DO NOT AGREE WITH AND ACCEPT THE STATED TERMS AND CONDITIONS, YOU WILL NOT BE ABLE TO ENROL TO THE EVENT.

Art. 1 - Preliminary versus finalized programmes: Preliminary programmes are those still being refined in terms of schedule, routing and locations, and/or in terms of the structures that will be used. The organising company, INTERNATIONALE ST. MORITZER AUTOMOBILWOCHEN AG (hereafter referred to as “the Organization” and/or “ISMA AG”) hereby affirms that it will maintain the services and structures shown in the finalized programme. However, in the unlikely event of services becoming unavailable due to circumstances beyond its control, it reserves the right to substitute them with services and/or structures of equal quality.

Art. 2 - Hill Climb for Historic Cars: the Regulations of the Competition are based on the FIA International Sporting Code (“ISC” and/or the “Code”) and the National ASN (Autorité Sportive Nationale) Regulations.

Art. 3 - Cars Admitted to the 2021 Hill Climb “Bernina Grand Prix” and Eventual Protests Regarding Non-admission: a maximum of 80 cars will be allowed to take part in the event, accordingly to the eligibility criteria and categories set by the Event Regulations. A Selection Committee - the sole authority deciding who may take part - will decide which cars are indeed entered, its decision being final. Once accepted for entry, cars cannot be substituted. No protests as to refused entries will be taken into consideration.

Enrolment: from 23rd December 2020 to 30st May 2021.

Acceptance of cars: throughout the enrolment process until 22nd June 2021.

The application will only be accepted together with a deposit of CHF 500 to be made by bank transfer using the account details communicated in the entry form; without the payment of the deposit, the application will not be examined.

In case the car is not accepted, the CHF 500 deposit will be refunded. In the event of acceptance, the CHF 500 will be deducted from the participation fee and the Entrant has to proceed immediately in the payment of the full entry fee according to the services requested.

The Organization is not responsible for any costs incurred in order to submit the application, both in case of refusal or acceptance with regard to the participation at Bernina Gran Turismo 2021.

The Entrants are allowed to form and enrol in teams formed from n. 4 cars and be charged of a special "team fee" (see article n. 6 of this same document) at the condition that all the 4 cars will be accepted from the Selection Committee. Should the acceptance not involve the whole team, the accepted Entrants will be charged with the planned individual fee.

Art. 5 - Advertising: Forms of advertisement allowed are ruled inside the Hill climb Bernina Gran Turismo Regulations and are conformed to the Appendix K to the International Sporting Code (ISC). The Hill Climb Bernina Gran Turismo Regulations form an integral part of the general provisions. During the scrutineering, the Organization and the event officials are authorized to cover or to remove from all vehicles any kind of publicity that does not conform to the above rules. Further checks will take place throughout the event.

Crews that do not adhere to what is stated in this article and the Regulations will be awarded penalties and any damages caused to the Organization will be charged to the offenders.

Entrants will be obliged to release the Organization from any responsibility and/or damages to the Organization and to 3rd parties in general and any compensation that is due to these will be at the entrant's expense, as a consequence of violating the aforementioned regulations.

Art. 6 - Entry Fee (Services included)

The entry fee – CHF 2'650,00 - includes the following items **for N. 1 people:**

- Welcome Aperitif on Thursday, September 16th
- Light lunch on Friday, September 17TH
- Technical briefing on Friday, September 17TH or Saturday, September 18TH [drivers who couldn't attend on September 17TH]
- Welcome cocktail and Event Official Dinner on Friday, September 17TH
- Coffee breaks on Saturday, September 18TH and Sunday, September 19TH
- Lunch and Dinner on Saturday September 18TH
- Hill climb "Bernina Gran Turismo" management
- The event starting numbers
- Welcome kit

Further services and assistance included:

- Parking in the locations where planned along the Event
- Security surveillance for the cars at Bernina Ospizio (Friday 17th and Saturday 18th September) all night long
- Coordination on the part of our staff throughout the Event

The entry fee for codrivers /guests / partners is CHF 750,00 and includes the same items mentioned above.

The team (formed by n. 4 cars) fee (see Article 3) is: CHF 9'600,00.

The fee for Mechanic/Technical Staff/Service Team is: CHF 200,00 (1 person)

Art. 7 - Entry Applications and Objections to the Entry Fee: the would-be entrants must complete the Entry Application form and send it – together with the requested documents/pictures - by mail to the addresses / contacts indicated in the Entry Application Form, by the indicated deadlines in the same document.

The entry fees (Art. 6 above) are defined by the costs sustained by the Organization to run the Event, together with the service offered and included. These costs include, for example, production, distribution and printing expenses, overall coordination of the Event, financial pledges on the suppliers, all the personnel involved amongst the other features.

Under no circumstance whatsoever and at no time will the Organization take into consideration any disputes regarding renegotiation of entry fees. The fee will not be renegotiable or refundable even in part after the event is over.

In case the application of an entrant is not accepted, his entry fees will be refunded deducting the banking fees or commissions incurred. These fees will be refunded via bank transfer or credited to your credit card.

Art. 8 - Renunciation: Partial or total renunciation of participation in the event must be given in writing by the participant, by means of an e-mail to the company address info@bernina-granturismo.com

No reimbursement will be given to entrants who do not show up at the scrutineering and/or the starting line or who withdraw during the course of the Event.

No fees will be reimbursed if an entrant cannot take part in the event due to invalid or insufficient personal, travel, or car documents.

No substitution of competitors is allowed after entry applications have closed.

Likewise there will be no refund for all those who have withdrawn from the event as a result of traffic accidents and mechanical defects or otherwise accidents, or accidents occurred with cars taking part in the race or with individual cars not participating at the event itself.

Any other different case might be submitted to and evaluated by the Organizing Committee, which only as a gesture of goodwill has the final judgement on these features.

One member of the participating team may be substituted up to the point in time when document scrutineering takes place at the Bernina Pass, with approval of the Organizing Committee. In the time between technical scrutineering and communication of the final Starting Grid, the additional approval of the Clerks of the Course is required.

A first substitution incurs no additional charge. Any further changes are subject to an administration fee of CHF 50.00 + VAT 8% due upon application.

Fees shall be refunded as a gesture of goodwill as follows at the sole discretion of the Organizing Committee in accordance with the above mentioned conditions:

- 75% if communication is made before close of entries on 30/05/2021
- 50% if communication is made before 15/06/2021
- No refund if communication is made after 15/07/2020
- Refund will be paid within 60 days from the date of communication of retirement

There is no legal claim for reimbursement.

Art. 9 – Causes of “Force Majeure”: in the event of any acts of “force majeure”, the Organization will be released from any obligation to provide the services stipulated and will be held blameless for the above or similar, as it will not be in a condition to carry out these services. The term “force majeure” encompasses in particular the following: strikes, bad weather conditions, wars, civil or military disorders, uprisings or riots, natural calamities, pillaging, arbitrariness of public authorities, acts of terrorism. If one of these events occur and it is no longer possible to provide services, entrants and/or crews will waive the right to any reimbursement, compensation or indemnity with regards to the total amount paid by the entrant if the Organization has to use the sum to cover the costs of organizing the Event. The only possible exception to this would be in the case of damages covered by the insurance policy regarding the 2021 Hill Climb “Bernina Gran Turismo”, set up by the Organization.

Art. 10 - Protection of Privacy Law Concerning the Protection of the Confidential Nature of Personal Data (DSG): in accordance with Swiss law protecting the confidential nature of personal data (Bundesgesetz über den Datenschutz [DSG] issued June 19, 1992 [Version January first, 2014]), the name of each participant is inserted into a database whose sole proprietor is INTERNATIONALE ST. MORITZER AUTOMOBILWOCHEN AG. INTERNATIONALE ST. MORITZER AUTOMOBILWOCHEN AG may use the information contained therein to send informative material about their activities, or advertising from sponsors and/or partners. In accordance with Swiss law entrants, clients, or whoever is in the database, can at any time, modify or cancel the information via an official communication to be sent to INTERNATIONALE ST. MORITZER AUTOMOBILWOCHEN AG.


If they wish to oppose any usage of their personal data, they can do so by sending a registered letter to INTERNATIONALE ST. MORITZER AUTOMOBILWOCHEN AG, Via Pros da God Sur 27 – 7504 Pontresina (CH).

Art. 11 - Additional and/or Informative Communication Bulletins: The Organization reserves the right to make known to all participants, by means of the above bulletins by post, mail and/or website, any changes or additions to the present Terms and Conditions and to the programmes. The Bulletins will also communicate extra information and explanations for better understanding and for the interpretation of the above.

Art. 14 – Insurance and indemnity: Each participant shall take part on his own responsibility. The organizer refuses all demands and claims for injury/damage to person/property of participants, drivers, assistants and third parties. In accordance with the Swiss law the Organization has drawn up a civil liability insurance policy for races and competitions, which also covers third party liability for the Organization and any bound persons for damage to persons, animals and objects, excluding injury to entrants themselves and their cars. Furthermore, no liability shall be assumed. Entrants agree to obtain insurance in conformity with current law and agree to release the Swiss Automobile Club, Auto Sport Schweiz, the Organization and any of their staff or collaborators involved in the Event, race marshals and owners of land and property through which the Event passes, from any responsibility for damage or injury to themselves, their drivers, co-drivers, employees and objects, or damage or injury caused to third parties or objects belonging to them, their drivers, co-drivers, employees or appointees.
